

## TECHNICAL HEALTH SCHOOLS NETWORK OF THE UNION OF SOUTH AMERICAN NATIONS (RETS-UNASUR)

## WORK PLAN 2014-2015

## PRESENTATION

The Technical Group for Development and Management of Human Resources in Health of the Health Council of the Union of South American Nations (Unasur) meeting for the first time in September 2009, in the city of Rio de Janeiro, approved for the Board of Ministers the creation of Networks of Structuring Institutions in Health, among them, the Technical Health Schools Network (RETS-Unasur).

In November of the same year, the Council approves a resolution on the subject. In December, during the 2<sup>nd</sup> General Meeting of RETS, the RETS-Unasur. Four months later, the Ministers publish a new resolution recognizing the creation of RETS-Unasur, which now operates as a sub-network of RETS, as a strategy to promote greater organicity to the cooperation activities between the countries. Joaquim Venâncio Polytechnic School of Health (EPSJV/Fiocruz), the headquarters of the Executive Secretariat of RETS, is indicated as the institution responsible for managing RETS-Unasur until 2013.

This document presents the proposed Work Plan for the biennium 2014-2105 of RETS-UNASUR, discussed and approved by the Network members present at its second meeting, held in Recife-PE, Brazil, on November 7<sup>th</sup> and 8<sup>th</sup>, 2013. The central idea of this Plan, in line with the proposal of a Commitment presented by Unasur/Health at the 3<sup>rd</sup> Global Forum on Human Resources for Health, held in the same city, from November 9<sup>th</sup> to 13<sup>th</sup>, is joining forces in an action mapping within the government, the issue of education and work of health technicians in 12 countries of the block. Without losing sight of the issues addressed in the Five Year Plan of Unasur-Health, this proposal represents an attempt, within the Network, to systematize the enormous diversity and complexity of arrangements that permeates the area of technical education in health in different countries, so to facilitate the establishment of multilateral cooperation actions in health within the Block.

This survey and subsequent systematization of the information collected should point out the similarities and specificities of each country in this area in order to facilitate dialogue and cooperation activities in the education and work of health technicians in the region, in addition to base for discussions taking place in the various sub-regions on this topic. The aim of the study is to find, among other things: Which Ministries and government agencies are involved with the issue of work and education of health technicians? What is the legal framework that guides this education? Who regulates the technical professions? What are the levels of technical education in the country?
